We can assist in obtaining this document prior to your arrival so please contact us to make arrangements for you. We also offer tuition holidays which enable you to obtain the relevant certificate during your stay but self drive usage is not available until the required level of competence is achieved.

Any false declarations on the above form will result in voiding our insurance and any claim that you may have against Quaysport Menorca caused by default of our equipment. It may also make you liable for any third party action that may arise. By completion of this form and the signing thereof, you accept the terms and conditions overleaf. Quaysport Menorca does not consider that signing of this form commits them to offer the holiday requested. However, Quaysport Menorca will confirm your reservation once you have been notified of the availability of the dates requested and on receipt of full booking deposit.

TERMS AND CONDITIONS

1. This contract is entered into with Quaysport Menorca S.L (“Quaysport”), the provider of all services hereby contracted for.
2. All details completed by the client on the Booking form overleaf must be factual and proof may be required to substantiate any declaration made. We reserve the right to cancel any booking should a false declaration be made.
3. All principals must be a minimum of twenty five years old and be totally and wholly responsible for the others in their party and the actions of the same.
4. The principal or other declared qualified certificate boat handler must be on board the vessel concerned at all times. No unqualified or inexperienced person is to drive the boat at any time.
5. No reckless or careless driving will be tolerated and any breach of local laws or any guidelines laid down by the representative of Quaysport may result in the termination of the use of the boat for the remaining period of the holiday. No compensation or refund will be made or considered.
6. A Booking deposit will be required to confirm your holiday (see table below). This deposit will be held throughout your holiday and will be returned after the end of the holiday assuming that the boat is returned in “as hired” condition. Any accidental damage, including propellers, third party or damage occasioned by misuse or abuse is to the client’s deposit account in full.
7. After receipt of your Booking deposit, confirming your holiday, Quaysport will render a Statement, which must be settled no less than eight weeks prior to the arrival date. Should you book a holiday with less than eight weeks to the arrival date, the Statement is payable on receipt. We strongly recommend that you take out adequate cancellation insurance, since we are unable to refund deposits or full payment unless the holiday has been resold. If cancellation occurs within the eight week period between Statement and arrival and the account has not been settled, we reserve the right to claim the full cost of the holiday from the client unless resold. In the event that your chartered vessel is damaged and becomes un-seaworthy whilst under your responsibility no alternative vessel will be provided and no refund for the unexpired period of your charter will be made. If the vessel has to be lifted out of the water for repair the cost of alternative accommodation is for your account.
8. Boats will be fuelled prior to the arrival of the client and fuel deposit will be charged at time of Statement. Any unused fuel deposit will be fully refunded to the client along with the Booking deposit.
9. Whilst the boats have allocated moorings available for them in Cala Llonga free of charge, the boats may be moored in other locations. They are only allowed to be moored overnight in a secure marina berth as approved by Quaysport – at no time during the hours of darkness are the boats to be under way or anchored off at any location. Failure to adhere to this stipulation voids our insurance and the charter agreement. Should this not be possible through mechanical failure or inclement weather conditions, telephone contact must be made before 7pm to inform Quaysport and to allow them to take necessary remedial action. We would ask charterers to telephone our office to inform us of the whereabouts of the boat each night.
10. Skipper – Available at £150 per day (inc IVA) returning to Home Port. £200 per day (inc IVA) away from Home Port
11. Despite the necessary Terms and Conditions as laid out above, we hope that you have a wonderful holiday but we cannot be held responsible for weather conditions. Should the representative of Quaysport Menorca, who is extremely experienced and has a great deal of local knowledge, make the decision not to allow the boats to leave the moorings on a particular day, his decision is final and absolute.
12. We cannot be held responsible for the actions of third parties whilst you are on holiday with our company.
13. Smoking is not permitted on any of our boats.
14. Please refrain from using oily Sun Cream especially P20 as they are likely to stain the vinyl.
15. Storage is limited on the vessels so please bring soft luggage bags
16. All disputes will be conducted under Spanish Law.

Frequently Asked Questions?

Q – What are the Embarkation and Disembarkation times?

A - The embarkation time is usually 15.00 hrs on the first day of the charter but we always try our utmost to make this earlier. Disembarkation time is 10.00 hrs on the final day of your charter.

Q- What is included

A- The vessels are fully cleaned and prepared; All bed linen including sheets, pillows, shower towels, hand towels, tea towels. All our vessel are fully equipped with all kitchen equipment, plates, glasses, pans, cutlery and utensils. Navigation aids including local charts and pilot books, ships equipment instructions manuals. Allocated Private mooring in Cala Llonga. For more than a week's charter a linen change is provided. If more regular changes of towels/linen are required this can be arranged and charged to your account.

Q- Service from Quaysport?

A- From the time you arrive at Mahon airport we are there to assist you. We greet you at the airport and help you board the vessel. During your stay our Quaysport staff are there to advise and help you with any issues be it recommending the best bays to visit or finest places to dine. A weather forecast is available each day and our staff will recommend which direction to head in.

Q- Fuel Arrangements?

A- Every vessel is fully fuelled at the start of your charter. You have a choice of re-fuelling on your last day and we then re-fuel and calculate the fuel charge from your deposit. Alternatively, you can refuel yourself and be returned the Full Fuel deposit.

Q- Safety?

A- All of our Charter vessel are fully inspected, licensed for commercial use and comply with both UK and local Spanish regulations, which require full safety equipment onboard to include – Extra Lifejackets, Liferaft, Fire Extinguishers, Flares and Signals, Life Horseshoes, binoculars and many more items which are listed onboard.

Q- Is it a Safe Cruising Area?

A- Menorca is very safe cruising area with a few shallow rock hazards which are clearly marked on the navigation charts. We will also advise each day of where to cruise to depending on the weather and point out where to avoid.

Q-What extras are there?

A- The only extra you should expect to have is the Diesel Fuel. The advantage of where we are based is that you do not have to travel far each day to find the best beaches.

Q- How is Menorca different to Mallorca?

Menorca is very different from both Mallorca and Ibiza not just because it has managed to escape the worst ravages of mass tourism but with its white sands and clear turquoise waters and the combination of dunes and woodland this island is a very well kept secret.
